#### **NEW BUSINESS:**

# • Conversations with Chinook Winds Region Admins: merger plan for discussion

Our current board; Sally, Chloe, and Rondy; have been in conversation with Chinook Winds' administrators' group. They are a newer group, with smaller numbers, and we have been discussing merging our regular online meetings with theirs. Our numbers here in Northern Spirit have been smaller since Covid, and we are mostly meeting online. Many topics we look at are applicable to admins in both Regions. This would change the structure of our meetings, so that both groups would have separate business meetings with their boards, and separate in-person gatherings (for example the Christmas & Spring lunches/potlucks). The regular monthly Zoom gatherings would be joint, and the Regions would take turns planning and leading educational or presentation meetings. We are hoping that this could bring even more opportunities for professional development, collegiality, and chances to share resources, ideas, and energy. This would also be good timing for us in Northern Spirit, as we currently don't have a Chair – so we would not be responsible for planning and leading every month's meeting.

For information, Chinook Winds Region includes Southern Alberta, including Red Deer, Banff, Calgary area, etc.

The admins discussed this possibility. It was mentioned that a retreat for Northern Spirit and Chinook Winds specifically might be productive and specific. The question of confidential information was brought up — whether there might be concerns around sharing information between Regions. This issue was discussed thoroughly. Overall admins seemed to agree that any information shared within Northern Spirit's meetings could most likely be shared with Chinook Winds as well, since overall collaboration and communication should be encouraged. Any very personal, sensitive, or classified information, such as employment or financial details, probably wouldn't be appropriate to share in any admin group or network.

# Approval of Rondy Kyle as an Executive of the Board and Acting Chair

We are still looking to round out our Board, and Rondy Kyle, admin at Trinity United in Edmonton, volunteered to join as an Executive member and Acting Chair when needed.

Adriana moved that Rondy Kyle be approved as an Executive of the Board, and Brittany seconded.

# Motion: Executive Board as decision-making body

As the connection to Chinook Winds' admins is pursued, if we have separate meetings for business (for example Treasurers' reports, approval of minutes, etc.), those will be open to anyone who wishes to attend, but we expect they will largely be attended by the board. A motion was proposed to give the Board the authority to make those business decisions and pass motions in that capacity.

Brittany moved to approve the Northern Spirit Administrators' Association's Board as decision-making body, and Sylvia seconded.
